Purpose:

The Nancy M. Albert Nursing Research Excellence Award was developed to recognize research excellence by Cleveland Clinic nurses, to raise awareness of the value of evidence-based practices that result from nursing research and to encourage RNs to think innovatively, develop research questions, conduct research, disseminate research findings, and ultimately translate research findings into practice. It is bestowed to one RN each year after a peer-review process.

Eligibility:

Any Registered Nurse employed full-time or part-time in the Cleveland Clinic health system. The nominee must have achieved "commendable or higher" expectations at their last annual performance review.

Process:

Any employee, physician, patient, or volunteer may nominate. Recipients will be selected based on evidence provided by completion of the nomination eligibility criteria. Nurse scientists from the Office of Nursing Research and Innovation and the Nursing Institute Research Council will be the reviewers for this award.

Award:

The award winner will be announced during Nurses' Week.

- 6. Describe how the nominee's behaviors align with the **Cleveland Clinic values** of Teamwork, Innovation, Service, Quality, Compassion, and Integrity. Cite specific examples for at least three of the six values.
