A Letter from the CEO and President



Dear Friends:

The first half of the year has been an extremely busy one, and I'd like to take you on a virtual road trip to provide you with an update on how we are expanding access to our world-class care across southeast Florida.

We begin in Vero Beach, where Cleveland Clinic and Indian River Medical Center (IRMC) and the Indian River County Hospital District have been working on finalizing an agreement to bring our model of medicine to the residents of the Treasure Coast. I'm excited about the opportunity this partnership presents, as Cleveland Clinic becomes an integrated, regional network in Florida.

Heading south on I-95, we make our way to Stuart-based Martin Health System, a nonprofit, community-based healthcare organization with three hospitals. At the beginning of the year, we launched a partnership between Cleveland Clinic's Sydell and Arnold Miller Family Heart & Vascular Institute and the Martin Health Frances Langford Heart Center to share best practices in cardiovascular medicine and heart surgery. Recognizing the synergies between our organizations, we now are exploring a broader strategic affiliation that could lead to integration and the regional expansion of Cleveland Clinic's services in Martin County.

As we continue south, we reach Palm Beach County, where in March, we opened our Wellington office. Since the opening, we have expanded our primary care team, adding two family medicine and internal medicine specialists. We soon will welcome a gastroenterologist, broadening the scope of care offered in Wellington.

About 30 miles south on the Florida Turnpike and a jog west, we come to our newly constructed Coral Springs Family Health Center. In July, we celebrated the opening of this facility, which offers specialty care, outpatient surgery, endoscopy and advanced imaging services. Our Parkland office, where patients can receive primary care services, is just two miles away, so the residents of Coral Springs and Parkland now have access to a full spectrum of Cleveland Clinic services right in their own backyard.

The last leg of our virtual road trip brings us to our main campus in Weston, which once again is home to South Florida's Best Hospital. *U.S. News & World Report* recently ranked us the No. 1 hospital in the Miami-Fort Lauderdale metropolitan area, with two nationally ranked specialties: Gastroenterology and GI surgery ranked No. 25 and Orthopaedics ranked No. 42.

This achievement is particularly gratifying as we prepare for the opening of our new 221,000-square-foot hospital bed tower and expanded Emergency Department in Weston. Combined with outpatient surgery in Coral Springs, the expansion of our Weston hospital allows us to meet the complex needs of our patients and the communities we serve.

I am proud of our outstanding team of caregivers, who continue to elevate the level of care we provide our patients, reflected in the industry recognition we receive. We recently were honored with the 2018 Healthgrades Outstanding Patient Experience Award, placing us in the top 15 percent of hospitals in the nation for overall patient experience.

Cleveland Clinic Florida also was the first medical center in Florida and the second in the nation to achieve accreditation for rectal cancer care. In addition, we recently received national recognition for stroke care from the American Heart Association/American Stroke Association. Last, but not least, Cleveland Clinic Florida was named a Top 100 Hospital by IBM Watson as a result of achieving better survival rates, fewer complications and infections, shorter length of stay, shorter emergency department wait times and higher patient satisfaction scores.

For all these reasons and more, on Friday, Nov. 9, we will celebrate Cleveland Clinic Florida's 30th anniversary and our incredible growth and achievements. I hope you will join us for this celebration at the Marriot Harbor Beach Resort & Spa in Fort Lauderdale.

I thank all of you, our dedicated supporters, who help us fulfill the Cleveland Clinic mission.

30 years of Medical Excellence



1987

Cleveland Clinic purchases 320 acres of land in a prime location in Weston.



1996

Internal Medicine Residency Program is accredited.



1988

Cleveland Clinic Florida opens its first outpatient facility in Fort Lauderdale with a staff of 28 physicians.



1998

Cleveland Clinic breaks ground on a 43-acre site in Weston.



1989

The Colorectal Surgery Residency Program becomes the first accredited residency program in any specialty in Broward or Palm Beach Counties.



2001

A fully integrated, academic medical campus opens in Weston. It is co-owned with Tenet Health. With 81 physicians, the campus includes diagnostic centers, outpatient surgery and a 24-hour emergency department located in the innovative, 153-bed hospital.



1992

Cleveland Clinic Florida doubles in size and expands North Beach Hospital.



2008

Opening of West Palm Beach Health and Wellness Center, now known as the Tomsich Health and Medical Center of Palm Beach County, which offers 11 medical specialties and innovative specialty care.



1994

Medical staff of 63 physicians exceeds the space in the original Cypress Creek location, and adjacent buildings are leased to accommodate them.



2009

To accommodate needed expansion, Cleveland Clinic Florida leases space in the office park across from the Weston hospital and opens the Krupa Center.

Cleveland Clinic expanded its footprint beyond Ohio and opened Cleveland Clinic Florida in 1988. The first locations were Cypress Creek and North Beach Hospital in Fort Lauderdale. Today, Cleveland Clinic Florida is a fully integrated academic medical center with locations in Weston, Coral Springs, Parkland, Wellington, Palm Beach Gardens and West Palm Beach, with 254 physicians and 2,977 employees.



2012

Cleveland Clinic Florida is granted a Certificate of Need from the state to open Transplant Program (Heart, Liver and Kidneys).



2013

Medical offices are opened in Palm Beach Gardens and Parkland.



2014

Kickoff celebration and launch of The Campaign for Cleveland Clinic Florida, a \$100 million capital expansion fund to shape the future of healthcare in South Florida and beyond.

The Weston hospital is designated a Comprehensive Stroke Center.



2015

The newest Weston campus building, the Egil and Pauline Braathen Center, opens to house the expanded Pauline Braathen Neurological Center and Maroon Cancer Center.

Cleveland Clinic's Board of Trustees approves a \$302 million plan for Cleveland Clinic Florida that includes expansion of the Weston campus and a new medical building and ambulatory surgery center in Coral Springs.

Cardiac care is significantly expanded in Palm Beach County.

2017

A physical therapy suite opens in the Palm Beach Gardens facility.

Cleveland Clinic Florida becomes Broward County's largest provider of solid organ transplantation and the fastest-growing program in the state with the program's 500th transplant.



New medical facility in Wellington (March) and 72,000-square-foot Family Health Center in Coral Springs (July) opens.




Larry Haberman

Philanthropy's Impact |

Life-changing Medical Equipment for Stroke Survivor

On Oct. 11, 2016, 46-year-old Jason Stevenson finished work and began his daily sprint up eight flights of stairs to his car in the parking garage. But this day was different. As he reached the sixth floor, he says his right side suddenly “turned to jelly.” He crawled out of the stairwell and slowly made his way to the elevator, pushed the emergency call button and dialed 911 before collapsing.

Jason was having a hemorrhagic stroke.

After nine days in the intensive care unit, Jason spent two weeks in inpatient rehabilitation. Since then, he’s had two more brain surgeries, and his recovery continues.



As a CrossFit athlete, Jason was eager to improve his motor skills after his stroke, so he began weekly physical therapy sessions at Cleveland Clinic Florida. Michelle Pearl, PT, a neurology

physical therapist at the Pauline Braathen Neurological Center at Cleveland Clinic Florida, realized that despite his hard work, Jason wasn’t progressing as quickly as he could be. She had a hunch that a special piece of equipment called LiteGait® could substantially help in his rehabilitation.

LiteGait is a mobile gait training device that simultaneously controls weight bearing, posture and balance while an individual walks on a treadmill or the ground. It creates an ideal environment for treating patients with a wide range of impairments and functional levels. LiteGait provides proper posture, reduces weight bearing, eliminates concerns about balance, and facilitates the training of coordinated lower extremity movement.

However, the device is expensive and wasn’t in the annual budget. Knowing the impact it would have on Jason’s treatment and other patients with mobility issues, Michelle approached the leadership at Cleveland Clinic Florida. After hearing her appeal, Cleveland Clinic Florida CEO and President Wael Barsoum, MD, immediately allocated funds from Cleveland Clinic Florida’s Strategic Priorities Fund to purchase the LiteGait.

The Strategic Priorities Fund was established to provide support for areas of greatest need: equipment, medical education and research. Thanks to the generosity of patients and benefactors, the fund has been used to acquire leading-edge equipment such as a 3D imaging system used in the cardio-oncology program, a nuclear camera that detects underlying coronary artery disease, a Holter monitoring system that interfaces with electronic medical records – and now, the LiteGait.

LiteGait is a mobile gait training device that simultaneously controls weight bearing, posture and balance while an individual walks on a treadmill or the ground. It creates an ideal environment for treating patients with a wide range of impairments and functional levels. LiteGait provides proper posture, reduces weight bearing, eliminates concerns about balance, and facilitates the training of coordinated lower extremity movement.

Within weeks of using the new equipment, Jason began to show marked improvement. The difference in adding this therapy? “Life-changing,” Jason says. He continues to heal and hopes that his life soon will be back to normal with his wife and three children.

Today, as Michelle predicted, many Cleveland Clinic Florida patients are benefiting from LiteGait. “This device is helping so many patients each week, improving their confidence and overall health,” Michelle says. “I am so grateful to our supporters who made contributions to this fund.”

Couple Honors Cleveland Clinic Care and Strong Friendship with Major Gift

A longtime friendship with then-Cleveland Clinic CEO Floyd “Fred” Loop, MD, and his wife, Bernadine Healy, MD, and lifesaving heart care at Cleveland Clinic in Ohio in 1997 led Arnold and Pamela Sheiffer to direct a major gift to Cleveland Clinic Florida’s Heart and Vascular Center.

Now residents of Vero Beach, Florida, Mr. and Mrs. Sheiffer made a seven-figure gift to support an additional three-year cardiology fellowship position for a physician who is continuing to train in cardiology following a residency program. The couple’s gift fortuitously coincides with a new affiliation between Cleveland Clinic and Indian River Medical Center in Vero Beach, which was important to them.

While Dr. Healy and Dr. Loop passed away in 2011 and 2015, respectively, the Sheiffers still think of them fondly and remain grateful for Dr. Loop’s help in connecting Mr. Sheiffer with the physicians who took care of him at Cleveland Clinic after his heart attack.

“I’m 86, and I credit 21 years of Cleveland Clinic care as the reason I have such an incredible quality of life,” says

Mr. Sheiffer, who has a long family history of heart disease. He has become well-known at his John’s Island home’s fitness center for his daily workouts.

“We saw the importance of a cardiac fellowship and thought we should support something that adds to the research and educational area of Cleveland Clinic Florida,” Mrs. Sheiffer says. “The cardiology staff was so passionate about the importance of fellowships, and Fred and Bernadine were so dedicated to the future education of new doctors, we felt this was what we were meant to do. We sincerely hope that Cleveland Clinic Florida is able to build on this gift as without education, there is no future in medicine.”

During a recent meeting with Mr. and Mrs. Sheiffer, Howard Bush, MD, an interventional cardiologist at Cleveland Clinic Florida, noted that he was hired by Dr. Loop to join Cleveland

Clinic Florida nearly 30 years ago.

“I was recruited as an interventional cardiologist from my fellowship in Houston by Dr. Loop, who was the CEO in Cleveland, and by Dr. Carl Gill, who was our first CEO in Florida,” he says. The program has grown considerably since then, he notes. “The most rewarding accomplishment has been the growth and development of our programs. When I started, we were about 15 physicians,” Dr. Bush says. “Now, we have over 250 world-class physicians located on a magnificent and ever-expanding integrated medical campus. For some of the most complex medical and surgical problems, the residency and fellowship training programs have quickly become well-respected and very competitive.”

Robert Cubeddu, MD, Director of the Robert and Suzanne Tomsich Department of Cardiology, says the Sheiffers’ gift is important to Cleveland Clinic Florida and to medical training.

“These resources allocated to education ultimately translate to a better place to work, a better quality of care,” he says. “Patients benefit from that, and their children will also benefit

from it. Adding a third fellowship position for the 2018-2019 academic year has been a goal for many years.”

Elsy Navas, MD, who manages the cardiology fellowship program, also completed her fellowship training at Cleveland Clinic Florida, where she is on staff.

“Having this program means that we can take care of much sicker patients,” she says. “The cardiology fellows under our attending physicians are practicing very high-quality care. Fellows are our eyes in the hospital, actively monitoring all of our heart patients. They are in the ICU at night, taking calls, and they participate in surgeries with the lead heart and vascular surgeons, enabling us to provide exceptional care for our patients. Philanthropy has allowed us to expand our fellowship program and, as a result, the care we offer to our patients.”
