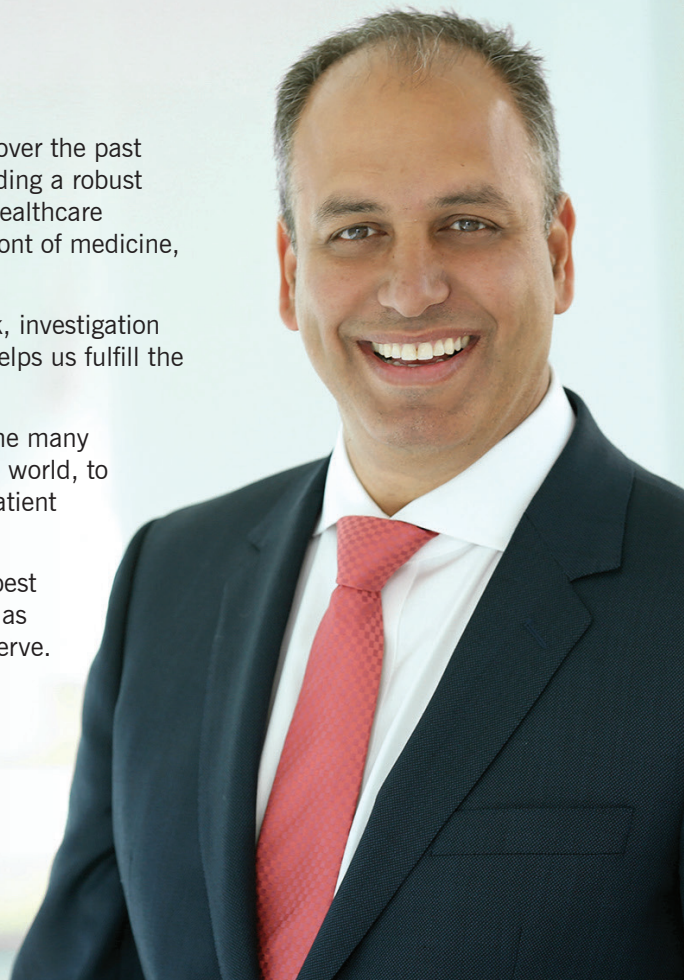

THE IMPACT of Your Philanthropy on Research

Clinical research has been fundamental to the mission of Cleveland Clinic Florida since its establishment in 1988. **More than 300 clinical trials** and several hundred research studies have been successfully conducted in Florida and have had a direct positive impact on the lives of patients around the world. **Numerous advances have led to improvements in both outcomes and quality of life.**



A highly skilled hematologist and researcher, Chakra Chaulagain, MD, is a prolific scientific author. His research focus is on blood cancer disorders in geriatric patients with an emphasis on improving the quality of care and enhancing cancer survivorship. Several of his patients made generous donations to support ongoing clinical research efforts at the Maroone Cancer Center.

Currently, there are **40 open clinical research trials** at Cleveland Clinic Florida.

As a result of the generosity of donors wishing to advance the treatment of neurological disorders, Cleveland Clinic Florida was able to fund two additional three-year neurology resident positions, which will include research and other activities.

Comprehensive strides are being made to improve the quality of life for patients living with Parkinson's, epilepsy, multiple sclerosis, Alzheimer's, dementia, stroke, tumors of the brain, spine and nerves, and other neurological disorders.

Benefactor Margaret Krupa continues to support research at Cleveland Clinic Florida, particularly in the area of geriatric conditions.

Good Morning/Sweet Dreams Program

Good Morning/Sweet Dreams is a patient-care program that was developed in 2012 and funded through philanthropy to enhance the patient experience. The volunteers are a trained group of teens and adults who visit patients three times a day to ensure through conversations, art, and games, that patients' needs are being met.

Improving Movement

Claude Robinson, a patient with Parkinson's disease, was treated by Cleveland Clinic Florida physical therapist Michelle Pearl, who is certified in the Lee Silverman Voice Treatment (LSVT) BIG program. LSVT BIG helps Parkinson's patients increase amplitude of limb and body movement (bigness) and improves trunk rotation/gait to advance speed in upper/lower limbs, balance and quality of life. Mr. Robinson was so impressed with the outcome of his treatment that he and his son, Jim, made a generous contribution to train more physical therapists in the LSVT BIG program to allow more patients to reap the benefits of the care he received.



"My son, Jim, and I are so pleased that our gift supported a LSVT GLOBAL training workshop for more than 70 physical therapists from the Southern region of the United States that included 11 of our own Cleveland Clinic Florida physical therapists. The impact of the LSVT BIG method will truly help the quality of people's everyday lives."

Scheduled to open in the fall of 2020, the Lozick Women's Center is dedicated to breast health and the screening, diagnosis and treatment of breast cancer.

Funded entirely through philanthropy, it will provide a seamless, holistic experience for patients in a newly constructed 6,800-square-foot space on our Weston campus.

"The Lozick Women's Center was developed in response to a growing need for a comprehensive subspecialty-based center dedicated to breast health and the screening, diagnosis and treatment of breast cancer. The center will provide world-class care for all women at all stages of life and accommodate women's health and cancer care in a convenient one-stop location. It will allow us to unite our various experts in this field from several departments in one welcoming location and provide awareness, prevention, and evidence-based guideline-directed care for women with female-based cancers. This center also will allow us to foster education and research as well as provide a wide range of support services specialized for women, such as acupuncture, aromatherapy, yoga and meditation, nutrition therapy and much more by licensed professionals."

Each year, the Cleveland Clinic Florida Ball supports the strategic priorities and immediate needs of the organization.

Donors' gifts were used to acquire leading-edge equipment including a 3D imaging system used in the cardio-oncology program, a nuclear camera that detects underlying coronary artery disease, and a halter monitoring system that interfaces with electronic medical records. Gifts also were used to create a physical therapy suite in the Palm Beach Gardens medical facility.

Another vital piece of equipment purchased through funds raised from the Ball benefits patients with stroke or spinal cord damage. Lite-Gait, a mobile weight-bearing device, creates a safe environment for the patient and therapist as the patient regains coordination and movement.
