| Introduction to Environment of Care | The purpose of the Joint Commission's Environment of Care Standards is to provide a safe, functional, supportive, and effective environment for patients, staff members, and other individuals in the hospital. | HIPAA Privacy Rule Courses: HIPPA Overview Patient Rights Privacy Practices Protected Health Information Specialty Groups | HIPAA education and training is required for employees of Health Care providers, payors, and companies that manage or process healthcare information. | Mandated by federal law | Take One Time Only | 75 minutes |
| HIPAA and Information Security Awareness | This course provides the user with general information and security awareness training to satisfy the requirements of applicable federal regulations (i.e., the HIPAA Security Rule and the Joint Commission of Accredited Healthcare Organizations (JCAHO) and Cleveland Clinic appropriate use policy. | Mandated by federal law and Cleveland Clinic Health System | Take One Time Only | 20 minutes |
| Patient Safety (Required for Patient Touching only) | Concern for the safety of the patient is the responsibility of everyone who works at Cleveland clinic because "Patient Safety Begins With You." | Preventing Occupational Exposure to TB (Required for Patient Touching and some Research only) | This course includes information required by the Occupational Safety and Health Administration (OSHA). | Recommended by the Centers for Disease Control & Prevention (CDC). CDC recommendations are enforced by the Occupational Safety and Health Administration (OSHA) under the General Duty Clause. | Take Annually (365 days) | 20 minutes |
| Basic Stroke Competency | Cleveland Clinic is designated as a Primary Stroke Center. Certification is granted by The Joint Commission on the basis that we meet the highest standards set by stroke medical experts in the areas of education, prevention, treatment and rehabilitation of stroke. This course meets one of the requirements for employee education. | Mandated by The Joint Commission | Take Annually (365 days) | 20 minutes |
