# Employee Flu Campaign

Receiving the flu vaccine – especially early in the season – protects yourself, each other and your patients. With the COVID-19 pandemic, it is even more essential for caregivers to protect themselves against the flu, an illness that can mimic COVID-19.

All caregivers are required to comply with our Influenza Immunization Policy by **October 31**. This means you must either get your flu shot or submit an approved religious or medical exemption by that date.

Regardless of where you work, you can walk in to any Occupational Health Department across our healthcare system to receive your flu shot throughout the season.

# Cleveland Clinic Employee Flu Program

The seasonal flu vaccine is a benefit available to all Cleveland Clinic caregivers. Yearly flu vaccination helps to reduce sick time, medical costs and the spread of flu — and helps prevent potentially serious complications from the virus. The best defense against the flu is getting vaccinated, and we encourage our caregivers to do so. Getting your free flu shot at any of the convenient locations offered across our health system protects you and reduces the risk of spreading flu to others — including your families and coworkers, and our patients and visitors.

## How to Comply with the Flu Program

#### Take these steps:

# Complete the brief Seasonal Flu Survey via your online ReadySet Account

You can access your secure ReadySet account like this:

- Log in at http://readyset.ccf.org (http://readyset.ccf.org)
- Enter your full Cleveland Clinic email address(with @ccf.org at the end) and your network password
- After you log in, click on "Health Surveys" at the left, then "Seasonal Flu Survey"
- · Fill out the survey and when prompted, sign and submit it

#### After completing the survey, do one of the following to comply with our Flu Program

- Get a flu shot at a Cleveland Clinic caregiver flu station (See Flu station locations for dates and times) or,
- Provide Occupational Health the documentation that you received a flu shot outside of Cleveland Clinic for example, at a CVS Pharmacy (although vaccinations outside our health system may not be covered by the Health Plan) or PCP, by following the instructions in "Verifying Outside Documentation" below; **or**,
- Receive a medical or religious exemption after completing the appropriate form and supplying documentation as described in "The Exemption Process" below.

## Verifying Outside Vaccination

#### If you get vaccinated by a Cleveland Clinic provider or Cleveland Clinic public flu station there are two options:

- Allow Electronic Transfer of your flu shot record from EPIC. Click the blue button "Epic Consent Form" to the right to authorize the transfer or,
- Provide written documentation such as a printed copy of your flu vaccination/immunization record from My Chart or have your healthcare provider print a screenshot of the record of your flu vaccine administration from Epic.

# If you get a shot outside our healthcare system — for example, a CVS pharmacy — provide a copy of the original flu vaccination document that includes:

- Your name
- Location where the flu shot was administered (examples: pharmacy name, Department of Health, etc.)

- Date of vaccination
- Vaccine manufacturer
- Lot number and expiration date of vaccine

## How to request a medical or religious exemption for getting a flu shot:

• There are separate forms to complete for medical and religious exemptions. Print and complete one of the forms below and send it to Occupational Health.

## How you will learn about your status

If you submit a request for an exemption, you will receive an email from OccHealthDoNotReply@ReadySetsecure.com (mailto:OccHealthDoNotReply@ReadySetsecure.com) that your request was either approved or denied. An approval means that you are considered compliant with the Flu Program. A denial means you will need to get the flu vaccine.
