

**2019 Cleveland Clinic Akron General Women's Board \$10,000 CASH RAFFLE\***  
**Official Rules**

The Akron General Women's Board ("Women's Board") of Akron General Medical Center ("AGMC") a tax-exempt 501(c)(3) organization, is sponsoring a fundraising raffle in accordance with the laws of the State of Ohio. The raffle shall be known as The Cleveland Clinic Akron General Women's Board \$10,000 CASH RAFFLE\* (the "Raffle"). Proceeds from the Raffle support the 2019 Akron General Women's Board beneficiary. The rules and regulations of the Raffle are set forth below. By purchasing a raffle ticket ("Ticket"), the purchaser agrees to be bound by these rules and regulations. The interpretation and application of the rules and regulations by AGMC and its legal counsel shall be final.

**Eligibility:**

The Raffle is open to all legal residents of the United States, who are 18 years of age or older as of the date of entry. All federal, state and local laws and regulations apply. Void where prohibited by law.

**To Enter:**

AGMC will sell Tickets at a cost of one hundred fifty dollars (\$150.00) per ticket. The odds of winning the Prize, as hereinafter defined, will depend on the final number of Tickets sold. Chances to win will not exceed 1 in 300. Ticket sales will begin on **July 8, 2019** and will continue up until the time of the drawing on **November 16, 2019**. Raffle tickets may be purchased by calling 330.344.6888 or email AGFoundation@ccf.org. All mail-in entries must be received by **5:00 pm on November 8, 2019**, you will receive an actual raffle ticket stub in the mail. All mail-in entry forms should accompany payment and checks should be made payable and mailed to the Akron General Foundation, 1 Akron General Avenue, Akron, OH 44307. The participant must follow all instructions on the entry ticket to complete the ticket entries and be qualified for the Raffle.

Per IRS rules, amounts paid for raffle tickets are not gifts to the charitable organization and do not qualify as deductible charitable contributions.

**Prizes:**

The "First Place Prize" (the first random raffle ticket picked) shall be a cash prize.

\*So long as One Hundred (100) tickets are sold, the First Place Prize shall be a cash prize of \$10,000.

If less than 100 tickets are sold, then the Raffle shall be a 50/50 Raffle and the First Place Prize shall be half of the total amount of ticket sales. For example purposes only, if 99 tickets are sold at the price of \$150, total sales is \$14,850, then the First Place Prize would be half of total sales which equals a cash prize of \$7,425.

The Second Place Prize (the second random raffle ticket picked) shall be a package to the The Blu Zone, which includes a certificate to the Blu Plate Restaurant, Blu Jazz+ Nightclub and the new Blu-tique Hotel (on select dates and other restrictions may apply). The total value of the Second Place Prize estimated to be Three Hundred Fifty Dollars (\$350).

Winner of the First and Second Place Prize must provide any information to AGMC where IRS Regulations require AGMC to report winnings to the IRS. AGMC and its legal and tax counsel will determine if such information is required and make a request of the Winner. Failure to provide such information within ten (10) days of such request shall result in an automatic forfeiture of the Winner's Prize.

The First and Second Place Prize are awarded "**AS IS**" with no warranty or guarantee, either express or implied by AGMC.

The Winner must claim the First or Second Place Prize within thirty (30) days of notification otherwise such Prize will be forfeited. In the event that a Winner does not claim the Prize or is determined to be ineligible to receive the Prize, no other Prize will be awarded or substituted.

AGMC reserves the right, at its sole option, to substitute a Prize of comparable value.

If a minimum of 67 tickets are not sold, AGMC reserves the right to cancel the drawing. If the drawing is cancelled, purchasers will receive a full refund. Cleveland Clinic Akron General, Akron General Women's Board or Akron General Foundation are not responsible for late, lost or postage-due entries.

## Random Drawing:

The Prize drawing will take place on **November 16, 2019**. One Ticket will be selected at random for the First Place Prize in accordance with Ohio laws by AGMC. . Another ticket will be selected at random for the Second Place Prize. The first Ticket selected that meets the requirements as set forth in these Official Rules will win the First Place Prize and the second ticket selected that meets the requirements as set forth in these Official Rules will win the Second Place Prize. The Prize will be awarded to the individual whose name appears on the Ticket (the "Winner"). Purchasers of the Ticket will not be deemed to be the Winner unless his/her name appears on the Ticket. The Winner(s) will be announced on the night of the event. The Winner(s) will be notified by the telephone and/or email addresses listed on the Winner's entry form. The Winner does not need to be present when the tickets are picked in order to win.

Only one eligible person may be entered in the Raffle per Ticket sold. If the name of more than one person is submitted with a Ticket purchase or the Ticket contains incomplete information, or the Ticket is otherwise deemed noncompliant with the Official Rules then that Ticket will be deemed to be void and another Ticket will be drawn. AGMC reserves the right to reject any Ticket purchase that is submitted with payment that does not constitute "good funds" or that is otherwise noncompliant with the Official Rules.

By entering the Raffle, the Winner agrees that his/her name and/or likeness may be disclosed to and used by the news media, or AGMC for promotional purposes without additional compensation. In addition, each participant releases the corporate entities of Akron General Medical Center and its respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the Raffle or winning the Prize, or resulting from acceptance, possession, use or misuse of the Prize. **The Winner of a Prize and/or their family, heirs, associates or other interested parties agree to indemnify and hold harmless the corporate entities of Akron General Medical Center and its respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all losses, damages, rights, claims and actions of any kind arising in connection with or as a result of the Winner's acceptance or use of the Prize.**

A Raffle participant's sole and exclusive remedy for AGMC breach shall be limited to the return of the purchase price paid for his/ her Ticket(s). In no event shall the corporate entities of Akron General Medical Center and its respective directors, officers, employees, volunteers and agents be liable to any party for any loss or injuries to earnings, profits or goodwill, for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages by counsel.

By purchasing a Ticket and choosing to participate in the Raffle, each Raffle participant acknowledges and agrees that AGMC has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason, and in such event, a participant's sole and exclusive remedy shall be to receive a refund of the full price paid by such participant for each Raffle ticket purchased, without interest.
