Lifeguard Instructor Courses

Learn how to teach the basic-level American Red Cross Lifeguarding courses and become eligible to teach many other ARC courses. Participant must be at least age 17 by the last date of the course and possess a current basic-level Lifeguarding certification. Candidates must have strong swimming skills and confidence in all land- and water-based Lifeguarding skills. All skills will be tested on the first day of the course. A 2-hour online training component must be completed before the first class date (information on back of flier).

Participants must be a current American Red Cross Lifeguard Instructor and/or Instructor Trainer in good standing in order to participate in this one-day course. This course is a requirement for LGIT and LGI recertification every two (2) years. With this course, participants have the option to certify or recertify their basic Lifeguarding. Expired LGI's may have the option to recertify their LGI through this course provided they have met the other requirements of maintaining their certification (call or email for more information). **All class times are 8:30am - 5:00pm.**

Water Safety Instructor Courses

Member \$210 | Guest \$250

Become certified to teach the courses within the American Red Cross Swimming and Water Safety program! Participant must be at least age 16 by the last date of the course and demonstrate an ability to perform swimming skills consistent with a Level 4 swimmer (information on back). All swimming skills will be assessed on the first day of the course. An online training component must be completed before the first class date.

Lifeguarding Instructor Course:

Candidates must be a minimum of 17 years old on or before the final scheduled session of this course and possess a current basic-level American Red Cross certification in Lifeguarding/First Aid/CPR/AED. Candidates must be prepared to demonstrate proficiency in all basic Lifeguarding (land and water) skills in order to participate in the course. Candidates will learn how to plan, organize and conduct the Lifeguarding courses in accordance with the policies and procedures set by the American Red Cross. Upon successful completion of the course, participants will receive a two-year certification, renewable when the instructor teaches and records the minimum required amount of classes, participates in any online updates (when applicable), and participates in the in-person Lifeguard Instructor Trainer and Instructor Review course every two years. The online portion of this course is specific to the course dates offered; therefore, the LGI candidate must first register for the course by calling or emailing the location where the course will be held. Upon registration, the candidate will receive an email with instructions and a link for the online content. Please note: This course does not renew your basic Lifeguarding certification. **Price Info:** Once the LGI candidate registers for the course through the Red Cross online link, he/she will be assessed a non-refundable \$37 fee to take the online portion. The remaining balance of \$173 (Member) or \$213 (Non-Member) will be paid directly to Lifestyles.

Lifeguard Instructor Trainer and Lifeguard Instructor Review Course:

This course is designed for currently certified Lifeguard Instructor Trainers and/or Lifeguard Instructors and is one of the requirements for recertification every two years. The primary purpose of this course is to provide updates and information to currently certified instructors and to ensure that all instructors are delivering consistent course content. Any new course content will be reviewed in detail, and water- and land-based skills will be practiced and polished. All candidates who register for this course MUST bring proof that they are in good standing; meaning you have taught the minimum number of classes necessary to maintain your LGIT/LGI certification and have completed any online content (when appropriate). Instructions on how to ensure that you're in good standing will be provided via email after you register. Payment will be expected on the day of the course.

Course Options:

- **Basic Lifeguarding:** Participants have the option of either **certifying or renewing** their basic Lifeguarding during this course for an additional \$40 fee to cover the cost of the ARC card. This can be done in conjunction with the course, and is a great idea so that all of your certifications can be due for renewal at the same time!
- **LGI Crossover/Re-Entry:** This option allows an opportunity for LGI's who have recently expired to recertify their LGI during the LGIT/LGI Review course. There is an additional fee, and candidates will be responsible for making sure they are still in good standing (instructions will be provided via email).
 - **YMCA Lifeguard Instructors** may also choose one of these class dates to crossover to American Red Cross. There are additional fees to cover the cost of the LGI manual and other materials, and participants must take a two-hour online orientation to the course prior to the course date. Therefore, early registration is required. Contact the location hosting the course for additional information.

Water Safety Instructor Course:

Candidates must be able to demonstrate the ability to perform the following skills consistent with an American Red Cross Level 4 swimmer: 25 yards each of Front Crawl, Back Crawl, Breaststroke, Elementary Backstroke, Sidestroke; 15 yards of Butterfly. Candidates must also be able to float and tread for at least 1 minute. Candidates will learn specifics of how to teach various age groups and ability levels. The course focuses on how to deliver quality, consistent and standardized content. Candidates will learn how to develop lesson plans & how to monitor the progress of participants while providing positive and corrective feedback. This is a two-year certification, renewable when the instructor teaches and records at least the minimum content required within the two years and completes any required online updates. The online portion of this course is specific to the course dates offered; therefore, the WSI candidate must first register for the course. Upon registration, the candidate will receive an email with instructions and a link for the online content.
