Medina Hospital Foundation BASH (Benefitting A Superior Hospital) Raffle Official Rules

Medina Hospital Foundation, a tax-exempt 501(c)(3) organization is sponsoring a fundraising raffle in accordance with the laws of the State of Ohio. The Raffle shall be known as the Medina Hospital Foundation BASH Raffle ("the Raffle"). All proceeds of the Raffle will go to the Medina Hospital Foundation and will be used to support Medina Hospital's mission to provide patient care, research and education in the community it serves. The rules and regulations of the Raffle are set forth below. By purchasing a raffle ticket ("Ticket"), the purchaser agrees to be bound by these rules and regulations. The interpretation and application of the rules and regulations by Medina Hospital Foundation and its legal counsel shall be final.

Eligibility:

The Raffle is open to all legal residents of the United States, who are 18 years of age or older as of the date of entry. All federal, state and local laws and regulations apply. Void where prohibited by law.

To Enter:

Medina Hospital Foundation will sell Tickets at a cost of \$50.00 (fifty dollars) per Ticket or \$100.00 (one hundred dollars) per 3 (three) Tickets (if the Tickets are purchased in a group of 3 by a single purchaser). Ticket sales will begin August 11, 2017 and end October 21, 2017 at 7:00 P.M. Eastern Standard Time. Tickets may be purchased in one of the following ways:

- 4. Online at www.MedinaHospitalFoundation.org. Follow all of the on-screen instructions, or
- 5. At the BASH on October 21, 2017 up until the time of the drawing.

The odds of winning a Prize will depend on the final number of Tickets sold. Per IRS rules, amounts paid for raffle tickets are not gifts to the charitable organization and do not qualify as deductible charitable contributions.

Prizes:

Grand Prize: The Grand Prize is a two-year lease for a 2018 Kia Cadenza (the "Kia"), approximately valued at \$10,700 (MSRP). Medina Hospital Foundation reserves the right, at its sole option, to substitute a prize of comparable value.

- The Grand Prize winner must enter into a written Lease Agreement with the Leasing Agent and subject to the Leasing Agent's approval of the winner's credit worthiness, the winner assumes and must pay all fees and charges, including, but not limited to, local, state, and federal taxes when the prepaid two-year lease on the Kia is transferred to the winner.

Random Drawing:

The Prize Drawings will take place at or about 7:00 PM eastern time on Saturday, October 21, 2017, at Weymouth Country Club in Medina, Ohio. One Ticket will be selected at random per prize in accordance with Ohio laws by Medina Hospital Foundation. The first Ticket selected will win the Grand Prize. A number will be attached to the Ticket relating to the number on entry receipt. Each prize, including the Grand Prize, will be awarded to the individual whose name matches the number on the Ticket selected (each a "Winner"). Winners do not need to be present to win. Winners will be announced at the BASH on Saturday, October 21, 2017, online at <u>www.medinahospitalfoundation.org</u> and in the Medina Hospital Foundation newsletter. Winners will be notified by the telephone and/or email addresses listed on the Winner's entry form. Winners must be 18 years of age or older and must prove eligibility.

By purchasing a Ticket, individuals enter the raffle activity and agree to be bound by all the rules and limitations of the Raffle. The Raffle is subject to all federal, state, and local laws and regulations and is void where prohibited by law. If declared a winner, such individual agrees that their name and/or likeness may be disclosed to and used by the news media and may otherwise be used by Medina Hospital Foundation for promotional purposes without additional compensation. By entering the Raffle, each participant releases the corporate entities of Medina Hospital Foundation and Bill Doraty Kia and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the Raffle or winning any prize, or resulting from acceptance, possession, use or misuse of any prize. Moreover, all prize winners agree to indemnify and hold harmless Medina Hospital Foundation and its respective directors, officers, employees, volunteers and agents from any and all losses, damages, rights, claims and actions of any kind arising in connection with or as a result of participating in the Raffle or the winner's acceptance of use of any prize. The winner of the Kia and/or their family, heirs, associates or other interested parties agree to indemnify and hold harmless the corporate entities of Medina Hospital Foundation and Bill Doraty Kia and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all losses, damages, rights, claims and hold harmless the corporate entities of Medina Hospital Foundation and Bill Doraty Kia and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all losses agree to indemnify and hold harmless the corporate entities of Medina Hospital Foundation and Bill Doraty Kia and their respective parent or affiliated companies, directors, officers, employees, v

Only one eligible person may be entered in the Raffle per Ticket sold. If the name of more than one person is submitted with a Ticket purchase, and that Ticket is selected as a winning Ticket, then the person named first will be deemed the holder of record of that Ticket and declared the winner. Division of the prize by a group purchasing a Ticket in common shall be to the sole responsibility of the person named as the holder of record of that Ticket, should that Ticket be selected as a winner.
