# Celebrating a 25-Year Legacy of Philanthropy

The Medina Hospital Foundation is celebrating a milestone anniversary, marking a quarter century of hospital progress made possible by philanthropy.

Since the first gift in 1991, the Foundation's mission has been to secure gifts from the community that will help support important hospital priorities including new construction, renovation and the purchase of equipment needed for patient care.

Over the years, gifts to Medina Hospital Foundation have advanced programs within the hospital and in the community.

Philanthropic gifts have supported:

- An Ambulatory Pharmacy in the hospital lobby
- Opening of a Congestive Heart Failure Clinic
- Renovation to provide space for Cardiac Rehabilitation
- "Kids Day of Safety and Play" on Medina's town square
- Equipment for volunteer fire departments to directly communicate with the emergency department
- Healthy Medina County

#### Witnessing the power of philanthropy

Robert Bux, an attorney and partner with Williams and Batchelder in Medina, was an original member of the foundation's board of directors and then the Chair for 14 years. Today, he serves on the hospital's board of trustees. He says he has seen firsthand what charitable contributions to the Foundation can do, including improving patient care and hospital services and promoting community health and wellness efforts.

"Occasionally, significant individual and family gifts to the foundation have paid for major projects all by themselves, such as The Jones Center for Women's Health at Medina Hospital and the emergency department addition to the Brunswick Family Health Center," Mr. Bux says.

The foundation fosters connections between the community and the hospital through special event fundraisers. Individual and corporate sponsorships of these events help further key hospital services and programs. Most recently, the Medina Hospital's BASH raised \$97,000 to support Healthy Medina County.

It should be noted that philanthropy isn't new to Medina Hospital. Back in 1944, local residents raised \$100,000 to convert the Weidner Family home into Medina Community Hospital.

Since the Medina Hospital Foundation was established, generous gifts have been instrumental in Medina Hospital's becoming a site for world-class care close to home. #### TRANSFORMATIONAL GIFTS

With a \$500,000 gift from David Jones, the Jones Center for Women's Health opened in 2000 at Medina Hospital. When patients go there for important medical services such as bone densitometry and ultrasounds, they will find that they also can be comfortable by having some refreshments, watching television or browsing the library. The center is designed to provide a homey environment and ease the stress of women having breast cancer examinations and treatments. Mr. Jones' gift was made in memory of his wife, Dorothy, and his mother, Kathryn, both of whom passed away after battling breast cancer. Mr. Jones was the first President of the Medina Hospital Foundation's Board of Directors.

A \$1 million gift by Donna and Cal Wible benefits Medina Hospital's heart patients. Mr. Wible, now retired, was a Medina Cadillac/GMC dealer. After having a heart attack in 1986 and being treated at Medina Hospital by what he described as an experienced and caring staff, Mr. Wible decided to show his gratitude by giving back. He and his wife have an estate gift establishing a permanent endowment for Medina Hospital's cardiac care department.

Hinckley resident Ken Cleveland, a prominent local builder, developer and philanthropist, and his wife, Patricia, made a \$4 million gift in November 2013 to Cleveland Clinic. Their gift, which supported construction of a 24,000-square-foot emergency department, is the largest gift to the Brunswick Family Health Center. The emergency department opened in July 2014.

"We appreciate every gift received at the Medina Hospital Foundation in the past 25 years, regardless of the size," Mr. Bux says. "The power of every gift has contributed toward Medina Hospital's ability to take care of patients and families and to improve the health of the community that it serves."

- In seven months, "Kirk" lost 34 pounds and lowered his blood sugar levels from the diabetic to the pre-diabetic range!
- "Jessie" needed motivation and accountability to stop smoking.
  She's now 10 weeks tobacco-free and has used the money she saved on smoking to buy a nice pair of walking shoes.
- At a Healthy Medina screening, "Sue" learned she was diabetic, with a blood sugar of 225. She changed her diet, lost 45 pounds and lowered her blood sugar to the 80's.

## Giving Thanks and Giving Back

The holidays are a time of fun, family and giving thanks. You can express gratitude in many ways, but one of the best is by making a year-end gift to a favorite charity such as Medina Hospital because of the benefits for both of you.

Charitable gifts provide a tax deduction, and you have flexibility in the amount, timing and choice of asset. At year-end, the most common forms of gifts include outright cash and appreciated stock, both of which provide a tax deduction for the year in which the gift is made. If you make a gift of appreciated stock, you also can avoid capital gains tax.

When you choose to give appreciated stock, you'll have a double tax benefit. In addition to receiving an income-tax charitable deduction for the full fair-market value of stock held longer than 12 months, you also can avoid potential tax on the capital gains.


