# Giving a Lift to Patients and Caregivers

Improving outcomes through the use of safe patient transportation techniques and modern mobility equipment is an important goal at Medina Hospital.

To achieve this, the hospital is introducing patient lifts, devices that permit caregivers to raise and transfer patients from a bed to a chair or the bathroom. Patients are placed in a sling suspended from the lift, which runs on rails from the ceiling.





The lift system will be installed in two rooms of the hospital's Intensive Care Unit (ICU). Until now, caregivers have been restricted to using either a manual lift technique or a portable lift appliance with a limited weight capacity.

Mobility activities for bariatric patients are a concern in the ICU.

"We're excited to have these lifts because we know they will make a real difference in patient care," says Donielle Finding. RN, ICU Nurse Manager.

Ms. Finding has been educating hospital staff on the use of the lift system and why it benefits both patients and caregivers.

"I emphasize that we can use the lifts for any instance in which moving patients presents a challenge," she says. "Such patients include those with gastrointestinal problems, those on ventilators or those who have experienced prolonged bed rest."

Philanthropic gifts will support installation of the overhead rails and lift system in rooms 10 and 12 of the ICU as part of the \$1.4 million renovation project underway.

"We would not have been able to provide this capability without the help of philanthropic gifts through the Medina Hospital Foundation," Ms. Finding says.

## "A" Rating

Patient safety is a top priority – and it shows! Thanks to the caregivers, Cleveland Clinic Medina Hospital earned an A rating from The Leapfrog Group in its spring 2017 Patient Safety Grades. This marks the third consecutive A for Medina Hospital.



The Leapfrog Group, a national healthcare rating organization, combines data from a voluntary, self-reported survey as well as various publicly reported metrics to produce a single composite score, which is published as a letter grade.

For many consumers, these grades, as well as other public rankings, are used to make their healthcare decisions. For Medina Hospital, this progress signifies our caregivers' commitment to high reliability, which strengthens our culture of safety and supports robust process improvement.

Initiatives supported by the Medina Hospital Foundation including Healing Services, patient transportation, staff education and new equipment contribute to Medina Hospital's exceptional patient care.

## LST Teams With Montville PD

Recently, the Cleveland Clinic Medina Hospital Life Support Team (LST) based in Montville Township was dispatched to a potential heart attack call. Dedication to new technology, regular training and equipment maintenance resulted in a remarkable success story for a local resident.

Township police officers and LST medics responded and started an EKG. Within

a few minutes, cardiologists at Medina Hospital and at Cleveland Clinic's main campus confirmed a severe heart attack, prompting an automatic cardiac alert.

The alert dispatched a helicopter to Medina Hospital to transport the patient to the main campus for advanced care. During the transport time, the cardiac team



prepared for his arrival and immediate surgery. The time from the 911 call to the time the patient was treated at main campus was only 59 minutes.

Our Foundation is proud to have used proceeds from the 2016 BASH gala to purchase mechanical chest compression systems for each LST ambulance. Please consider attending the BASH at Weymouth Country Club on Oct. 21.
