Service and Appreciation Span Decades

Medina Community Hospital opened in 1944 thanks to thousands of philanthropic gifts from individuals and businesses throughout Medina County.

Over the past 76 years, including its August 2009 affiliation with Cleveland Clinic, the hospital grew in size and stature. All the while, community members have recognized the hospital's importance to their health and well-being.

Those who support Cleveland Clinic Medina Hospital show their appreciation in many ways, including gift planning. Here are three stories of individuals who chose this type of giving to fulfill their financial and charitable goals.

Mutually Beneficial Giving

For years, Corinne Hadley served as an active member of the Medina Hospital Foundation's Board of Directors. "I did whatever I was told to do," she says cheerfully. "I'm a gofer."

Among her many volunteer activities, Hadley helped with the BASH (Benefiting A Superior Hospital), the board's annual fundraiser.

Raising money proved to be a passion, not a chore. "I love the foundation," she explains. "I love Medina Hospital."

During her tenure on the board, Medina Hospital became part of Cleveland Clinic. "It has been a pleasure to work with the people from the Clinic," says Hadley, who has deep familial roots in Medina. She's lived in the city for 33 years, and "I've been coming here since I was a baby," she says. "I see how everything has grown. It's astounding. The hospital is one of the best changes and how it serves the community."

In 2010, Corinne decided to make a \$5,000 gift to the hospital. With a satisfied chuckle, she describes talking a friend into doing the same. Together, the two established a charitable gift annuity, which benefits the hospital and pays them fixed quarterly payments.

"I really wanted to help the hospital," she says, "and I wanted to get money back. And it was nice for the hospital to get \$10,000."

Supporting the hospital was "a lovely thing to do," says Hadley, who's considering making another gift. "It was something I could and would do."

A 'Win-Win-Win' Situation

A husband and wife, residents of Lafayette Township since 2004, are making a significant philanthropic impact with insurance.

The couple, who are giving anonymously to Cleveland Clinic Medina Hospital, established a \$100,000 life insurance policy, with half benefiting pediatric services and the other half going to the hospital's Medical Staff Endowed Fund.

Their motivation includes the exemplary care given to immediate and extended family members at Cleveland Clinic facilities, from the regional health centers to main campus. "We support the institution," the husband says. "Cleveland Clinic has been important to all of our lives. We've had great care from this institution in many locations."

Their support of the Medical Staff Endowed Fund demonstrates "the power of endowment over the long term," he says. "The funds will continue to grow. The return on investment is going to be huge over the next 50, 60 years and then forever."

Describing how their life insurance gift works, he says, "We've committed to paying the policy premium. Because it's going to a non-profit organization, we're getting a tax advantage. It's sort of a win-win-win. Over the course of 10 years, there will be a four-to-one return."

A life insurance gift can be structured in different ways. "We took out a new policy and named Cleveland Clinic Medina Hospital as the beneficiary," he explains. "Once the policy was established, we transferred ownership of the policy to the

hospital. So the hospital now owns the policy and is the beneficiary of it. We pay the premiums

and receive a tax deduction for that."

Making a gift with life insurance allows the couple to make a greater impact than they ever thought possible.

That pleases them both. "There are a lot of opportunities in any area of Medina Hospital," he says. "And all the money is used on behalf of patients."

'The Right Thing to Do'

Longtime Medina resident Gail Houk, who has enjoyed a 31-year career in behavioral healthcare, started out at as a youth volunteer at Medina Hospital in her early teens. "Being able to volunteer in the hospital at a young age really opened my eyes to the wide range of career opportunities in healthcare," she says.

She had a particular interest in helping people with mental health issues and, after graduate school, she joined

Alternative Paths provides a range of behavioral health

services for individuals with mental illness and substance use disorders. It has a contract with Medina Hospital, Houk says. "If there's someone in the emergency room in need of Psychiatric Emergency Services, Alternative Paths is a local resource that the hospital uses."

Now a member of the hospital's Board of Trustees, Houk says, "I have watched the evolution of the hospital. Cleveland Clinic has brought so much to Medina Hospital in terms of excellent healthcare resources, staffing and specialty care."

> She and her husband, Marc, have included the hospital in their will, splitting their estate gift between the Emergency Department and oncology.


The couple learned early on the importance of giving back, she says. "Marc and I both were raised in families where there has always a strong motivation to give back to the community, and be a part of the community, with the idea that if we all contribute, then we all live a better life as a result."

The Houks consider Medina Hospital to be the best place for their philanthropy. "We just feel that it's the right thing to do for our community," Houk says. "There are a lot of nonprofits and small organizations in town that do great work. We wanted to find a way for our gift to reach the most people, through areas that have influenced our lives. We also know that this contribution will live on and continue to benefit the community."
