We appreciate your interest in Cleveland Clinic's WOC Nursing Education program (WOCNEP). This admission guide's content provides information about our online program, specialty courses and clinical rotation options, admission requirements and process, tuition and other financial considerations, as well as a link to our online admission application.

Our program was established in 1961 as the first WOCNEP of its kind in the world. It is accredited by the Wound, Ostomy, and Continence Nurses' Society<sup>TM</sup> with current accreditation through December 31, 2029.

Our curriculum is rooted in evidence and best practice that provides education focused on Professional Practice Concepts in WOC Nursing; Acute & Chronic Wounds Management; Fecal and Urinary Diversion Management; and Urinary & Fecal Incontinence Management. <u>This is a rigorous program with approximately 20+ hours in weekly</u> coursework. It is designed to prepare you for the role as a WOC Nurse specialist, and it's important for you to determine your best time to start the program.

A WOC Nurse specialist is vital in pre- and post-operative management of a person with an ostomy; instrumental in the prevention and treatment of pressure injuries, lower extremity wounds, fistulae, and other chronic wound and skin disorders; and provides specialized care for persons with urinary and fecal continence concerns. During the program, you will acquire the knowledge and skills to establish a WOC practice, and to provide the following: direct patient care and education, address psychological concerns, discharge planning, provide rehabilitative counseling, and follow-up care.

Our online courses include asynchronous weekly discussion threads, self-directed learning modules, individual assignments, and clinical rotation options, and a comprehensive final exam for each specialty course. All didactic course work is completed and submitted within the online learning management system (LMS). Prior to enrolling, you should consider all additional costs associated with this program. Some additional costs include textbooks, laptop, and clinical fees. Clinical fees may include preceptor fees, airfare, housing, food, living expenses, parking and local transportation fees, potentially lost wages, and/or childcare. These additional costs are the sole responsibility of the applicant / student.

If you are interested in admission, please proceed on to **Step 1: Select a WOC Cohort and Adhere to All Required Dates for Admission.** You may apply only during the "open admission" periods listed by completing and submitting your online admission application e-form located in **Step 2: Admission Requirements and Process.** Additionally, your \$200 non-refundable admission application fee must be remitted online at the time you submit your admission application e-form. <u>Each cohort's seating fills quickly and once seating has filled to maximum capacity, the online</u> admission application form automatically will close early and then become non-accessible until the next cohort's open admission period begins.

Upon receipt of your admission application, and \$200 nonrefundable admission application fee, our business office will initiate your admission onboarding event in our Rival admission onboarding system. Rival will email you a student user account and it will provide you with instructions to complete your admission onboarding criteria. Your assigned Rival admission tasks must be finalized by the cohort's posted "Final Date to Complete ALL Admission Requirements" posted on the annual class schedule. Additionally, your tuition must be paid in full by this date. Otherwise, you will not secure a seat in the elected cohort.

**Wound, Ostomy, Continence Nurses Society**<sup>TM</sup> (**WOCN®**) **Accreditation** –A WOCNEP that has been approved by the WOCN® Accreditation Committee, and it meets the minimum standards in providing WOC nursing continuing education based on the WOCN® curriculum blueprint and accreditation manual. Our WOCNEP is a WOCN® accredited program, and a separate business entity from the WOCN® Society and from the WOCNCB. WOCN® is the legal abbreviated trade name referring to the society, and it should <u>never</u> be used as a credential. The same is true for the WOCNCB.

**Credentialing Exam eligibility** Our WOCNEP is accredited by the WOCN® to provide continuing education in professional practice concepts, wound management, fecal and urinary diversion (ostomy) management, and urinary and fecal incontinence management education with the emphasis on the role of WOC Nurse specialist. Sixty (60) ANCC contact hours of nursing continuing education are awarded upon successful completion of each didactic course elected. Students also complete all corresponding clinical rotation requirements. Students who successfully complete our WOCNEP are eligible to test through the WOCNCB's Traditional Pathway to certification to earn their credentials. (NOTE: students who complete the Experiential Pathway must also meet WOCNCB's Experiential Pathway credential testing criteria.)

**Wound, Ostomy, Continence Certification Board** – The WOCNCB is a separate business entity from the WOCN® Society and from our accredited WOCNEP. The WOCNCB determines exam eligibility, and the knowledge level and skills needed for safe practice and awards the legally defensible credential based on successfully completed exams. Your practicum course with a clinical rotation election requires you to have an active, unencumbered, nursing license in the state where your clinical will be completed.

You must provide (upload in Rival) proof of licensure for the state of clinical. If you hold a multi-state license, verify the license allows you to practice in the state of your clinical before providing (uploading into Rival).

If you are not licensed in the state where your clinical will be completed, then review licensure options and notations below:

- Option one Apply now for a nursing license in the state where you will be completing your clinical rotation. Please note obtaining an out-of-state license can take between 4-16 weeks depending on the state.

- A clinical rotation must be started in coordination with the start of your final, 12-week, practicum course. Any delays in the start of your clinical rotation may result in your inability to complete this program within the required timeframe via the Traditional Pathway to WOCNCB credentialing. In this situation, you could be switched to the Experiential Pathway to WOCNCB credentialing and not be able to complete your clinical component.
- An advanced practice nursing license is not required for WOC nursing clinicals.

# **Step 2: Admission Requirements & Process**

#### **Admission Requirements:**

Applicants must meet the following criteria to be considered for admission:

- 1. Be actively licensed as Registered Nurse in the U. S. with a baccalaureate degree or higher.
- 2. Non-nursing baccalaureate degree holders must demonstrate competencies in health assessment, leadership and management, research and statistics, and community health nursing.
- 3. Have one year RN clinical experience following RN licensure.
- 4. Have current clinical nursing experience within the last 5 years prior to application.
- 5. Provide documentation in currency of clinical nursing experience within the last 5 years: current, active practice, completion of a nurse refresher course or a clinical performance examination.
- 6. Ability to attend program's didactic classes and to complete a clinical rotation in the U.S. without a student VISA.

Cleveland Clinic's WOC Nursing education program is unable to sponsor student VISAs.

## Admission Application & \$200 Non-Refundable Admission Application Fee:

To start your admission process, first complete and submit your online admission application e-form and \$200 non-refundable admission fee at: <u>Admission Application</u>

At the end of your application process, you will be routed to our program's secure financial payment system to remit your \$200 non-refundable application fee. We must receive your \$200 along with your admission application <u>before</u> you are entered into our Rival admission onboarding system. Rival will activate the start of your automated admission onboarding process, and the system will send you a welcome email with your applicant user account information and admission instructions. Wait time for your email generally is up to three business days.

Next Steps while you await your Rival welcome email and admission onboarding instructions:

• Order your official college e-transcripts and have them <u>emailed</u> directly from your college university's online transcript clearinghouse to our program at <u>WOCschool@ccf.org</u>. This is the necessary method of delivery, and we cannot accept paper transcripts mailed to a physical address.

If your university does not utilize an online transcript clearinghouse, then kindly call our business office (216-317-7163) first before you place your transcript order with your university. We will provide you with an alternate submission resolution.

- Ensure your resume or CV is current. You will be required to upload it into your Rival admission onboarding event. Resumes and CVs are thoroughly reviewed to ensure that you meet all admission requirements.
- If you elect to complete a clinical in your own state of residence, <u>then you must utilize an approved clinical site and</u> <u>preceptor from our program's clinical database</u>. To obtain a list of approved clinical sites and preceptors, email us an inquiry for your state of residence to <u>WOCschool@ccf.org</u>.

After you acquire the list of approved preceptors and clinical sites from us, it is your responsibility to actively contact preceptors to secure your clinical placement. All applicants must secure a preceptor and clinical site <u>before the</u> <u>cohort's Final Date to Complete ALL Admission Requirements as indicated on the class schedule.</u> Refer to Step 1: <u>Select a WOC Cohort and Adhere to All Required Dates for Admission</u> above. (Also refer to <u>Step 3: Practicum</u> Course Options for specific instructions.)

• Your practicum course with a clinical rotation election requires you to have an active, unencumbered, nursing license <u>in</u> the state where your clinical will be completed.

You must provide (upload in Rival) proof of licensure for the state of clinical. If you hold a multi-state license, verify the license allows you to practice in the state of your clinical before providing (uploading into Rival).

If you are not licensed in the state where your clinical will be completed, then review your licensure options and notations below:

- Option one Apply now for a nursing license in the state where you will be completing your clinical rotation. Please note obtaining an out-of-state license can take between 4-16 weeks depending on the state.
- Option two Apply for a multistate license if it includes the state where you will be completing your clinical rotation. Please note obtaining a multi-state license can take between 4-16 weeks depending on the state.
- Option three Choose another approved clinical site in a state where you are licensed.

#### **NOTES:**

- Nursing licensure applications do take time. Apply now for your licensure as quickly as possible because you will not be able to start your clinical rotation without the appropriate state nursing license. Temporary issued licenses may not cover your clinical rotation period. Ensure you apply for and receive a full state license in the state of your clinical.
- A clinical rotation must be started in coordination with the start of your final, 12-week, practicum course. Any delays in the start of your clinical rotation may result in your inability to complete this program within the required timeframe via the Traditional Pathway to WOCNCB credentialing. In this situation, you could be switched to the Experiential Pathway to WOCNCB credentialing and not be able to complete your clinical component.
- An advanced practice nursing license is not required for WOC nursing clinicals.

## Step 3: Practicum Course with Clinical Options: Traditional vs Experiential Pathway

## **Traditional Pathway**

A clinical rotation is required, and it may begin one week after successful completion of ALL elected didactic courses elected. There are three different clinical rotation options. A practicum course with corresponding clinical rotation option will be elected on the applicant's admission application form. Applicant must hold an active, unencumbered RN license in the state of clinical rotation prior to beginning clinicals.

1) **Full Hours Clinical Option - At Cleveland Clinic (N.E. Ohio)** – 40-hour clinical experience (per specialty course) at a Cleveland Clinic location in N.E. Ohio. Our clinical scheduling team will assign preceptors and will email your clinical schedule to you. <u>Seating is limited and issued on a first-come, first served basis at the time of admission</u>.

Clinical hours are scheduled Monday – Friday from 8 a.m. until 5 p.m., E.T. No clinical time is scheduled on Saturday or Sunday.

Travel, housing, transportation, parking and meals are the students' responsibility to make their own arrangements and pay for all expenditures.

- 2) Full Hours Clinical Option In Your Own State of Residence 40-hour clinical experience (per specialty course) to be completed in your own geographical area. You must select from approved preceptors and clinical sites from our program's clinical database. Contact us at WOCschool@ccf.org to acquire a list of approved preceptors and clinical sites in your state of residence. Refer to the notes section farther below.
- 3) Split Hours Clinical Option either at Cleveland Clinic or in your State Options and information above apply. However, a minimum of 24 hours per specialty course are required at a clinical site PLUS 16 hours are completed through virtual online clinical coursework per specialty. This option is ideal for those students who are unable to complete all of the required clinical hours at a clinical site. <u>Refer to the notes section below</u>.

#### NOTES:

- If your completing a non-Cleveland Clinic clinical rotation, and our program requires renewal of a student clinical affiliation agreement with your secured clinical site, then it is the applicant's responsibility to ensure either your preceptor or the clinical site's nursing education team emails us at <u>WOCschool@ccf.org</u> their student clinical affiliation agreement template. The agreement template must be provided in an editable MS Word format and emailed to our program <u>before your admission period's Final Date to Complete Admission Requirements as outlined on the annual class schedule</u>.
- If the approved preceptor(s), on our approved list given to you, have either terminated their employment at your secured clinical site, or they are not available to precept you, then you may work with the clinical site's nursing education team to source and secure a new CWOCN credentialed nurse / preceptor. In this event, the new preceptor must go through our program's accreditation review and approval process and obtain our program's approval to precept your clinical rotation. This approval must occur during your admission onboarding period. Please cut and paste our program's preceptor application packet below onto your prospective preceptor for immediate completion.

- Documented evidence of demonstrated completion for at least one of the following: 1) a preceptor workshop, or 2) other structured learning program which includes principles of adult learning, critical teaching strategies, and clinical evaluation methodology, or 3) evidence of prior preceptor or clinical nursing educator experience.

#### **Experiential Pathway**

No clinical rotation requirement. Nursing C.E. contact hours are awarded for each successfully completed didactic course elected. If desired, and prior to admission, the applicant must determine if they meet the WOCNCB's "experiential pathway" requirements to apply and sit for certification credentialing exam(s) after successful completion of this program. Visit WOCNCB's website for more details before selecting this option and direct any credentialing questions to that organization.

# Step 4: Tuition & Other Financial Considerations

Tuition fees listed below are <u>minus</u> the required \$200 non-refundable admission application fee. Textbook fees, clinical or precepting fees, travel, transportation, parking, lodging, and meals are NOT included in tuition fees.

- \$3,200 One specialty course (elect wound, ostomy, or continence) plus prerequisite professional practice concepts
- \$4,800 Two specialty courses (combination of wound, ostomy and/or continence) plus prerequisite professional practice concepts
- \$6,400 Three special courses (includes wound, ostomy, and continence) plus prerequisite professional practice concepts
- \$1,600 One additional specialty course (applies to returning students, who previously elected a single or a dual scope specialty track in a prior cohort)

*Tuition Payment Deadline:* Tuition payment, in full, must be received <u>before</u> the class' posted <u>Final Date to</u> <u>Complete ALL Admission Requirements</u> as indicated on our program's annual academic class schedule.

*Failure to Receive Tuition, in full, by the Posted Final Date to Complete ALL Admission Requirements:* If full tuition is not received by the Final Date to Complete ALL Admission Requirements, then the applicant's Admission will be automatically withdrawn, and the applicant will need to re-apply when admission registration re-opens for the next cohort or any subsequent cohort.

**Practicums:** Any associated clinical or preceptor fees, travel, housing, transportation, parking and meals are at the student's own expense and not included in tuition. Cleveland Clinic is not liable for any circumstances nor expenses incurred.

*Practicum Course Extension Fee:* Two, 4-week course extensions, at a cost of \$400 each, may be granted to allow for practicum course completion.

## Step5: Housing Options (for elected clinical rotations at Cleveland Clinic, in N.E. Ohio)

<u>Housing:</u> Each student is responsible for choosing and making their own housing arrangements along with all expenditure and liability for housing, travel, transportation, parking, meals, etc. Cleveland Clinic is not liable for any circumstances nor expenses incurred.

For clinicals elected at Cleveland Clinic (in N.E. Ohio), our clinical scheduling team will email you, thirty days prior to your first clinical date, your clinical orientation packet. Items in this packet include a (suggested) housing guide, clinical orientation guide, campus walking guide, and your clinical schedule.
