Ascertainment of Ohio pharmacist licensure as soon as possible, but must be licensed within 90 days of start date																									
Successful completion in each of the required rotation areas outlined in the Program Structure (Orientation, General ID Consults, Antimicrobial Stewardship 1 and 2, Immunocompromised ID consults 1 and 2, Microbiology, Endocarditis ID Consults, Bone & Joint ID Consults, Neurosciences ID Consults, Pediatric ID Consults, Longitudinal HIV/ID Outpatient Clinic, Longitudinal Leadership and Formulary Management, Research, Presentations/Education, and On-Call)																									
Completion of all PharmAcademic evaluations																									
Completion of the Appendix (Topic Tracker) of the <i>ASHP Required Competency Areas, Goals, and Objectives for Postgraduate Year Two (PGY2) Infectious Diseases Pharmacy Residencies</i>																									
Completion of a residency research project (large project)																									
Completion of at least one drug use evaluation (DUE) or quality improvement project																									
Completion and presentation of at least one formulary review monograph																									
Preparation or revision of at least one treatment guideline or protocol																									
A manuscript (in publishable form) written and submitted to the residency director prior to the end of the residency year																									
Present according to the schedule agreed upon by both the Resident and Residency Program Director at the beginning of the residency year (including presentations at resident conference, APPE student conference, and ID Monthly)

And by the end of the residency, there can be no objectives that are rated as Needs Improvement not followed by a Satisfactory Progress or Achieved during the residency.
