Our Purpose

The Main Campus inpatient program will prepare interns to become pharmacy practitioners that embody excellence in education, clinical care, and personal integrity. This program challenges student pharmacists to think creatively and critically while emphasizing diversity, innovation, and the commitment to putting patients first.





Program Details

When: This 3-year, longitudinal program is a **year-round paid internship** consisting of two 12-week summer components from May-August (between P1/P2 and P2/P3) and an average of one out of every four weekends throughout the academic year. Internship **start and end dates are customizable** based on final exam schedules and departmental needs.

What: The internship will cultivate a highly translatable skill set through two distinct tracks: clinical and operational. All interns will start rotations in pharmacy operations, sterile and non-sterile compounding, and drug information. Clinical rotations available include internal medicine, cardiology, emergency medicine, and critical care with electives in other clinical areas based on preceptor availability.

Every intern has the opportunity to participate in research, projects, and presentations.

Why: Our internship program provides **tangible**, **real-world experience** at the #2 hospital in the world. 

Eligibility

First year students are eligible to apply for one of two tracks: clinical or operational. To be eligible for selection, students must be in their first year of professional pharmacy education within an ACPE-accredited doctor of pharmacy program (either 1st year student in a 4 year program or 3rd year student in a 6 year program). Students beyond their first year in pharmacy school are eligible to apply for the operational track.

Students must be eligible for an intern license in the state of Ohio. If selected, the student will be required to obtain their license by April 1, 2022, and maintain for the duration of their employment.

Applicants will be evaluated on various parameters including career goals, prior experience, communication skills, and the ability to work in a dynamic team atmosphere.
